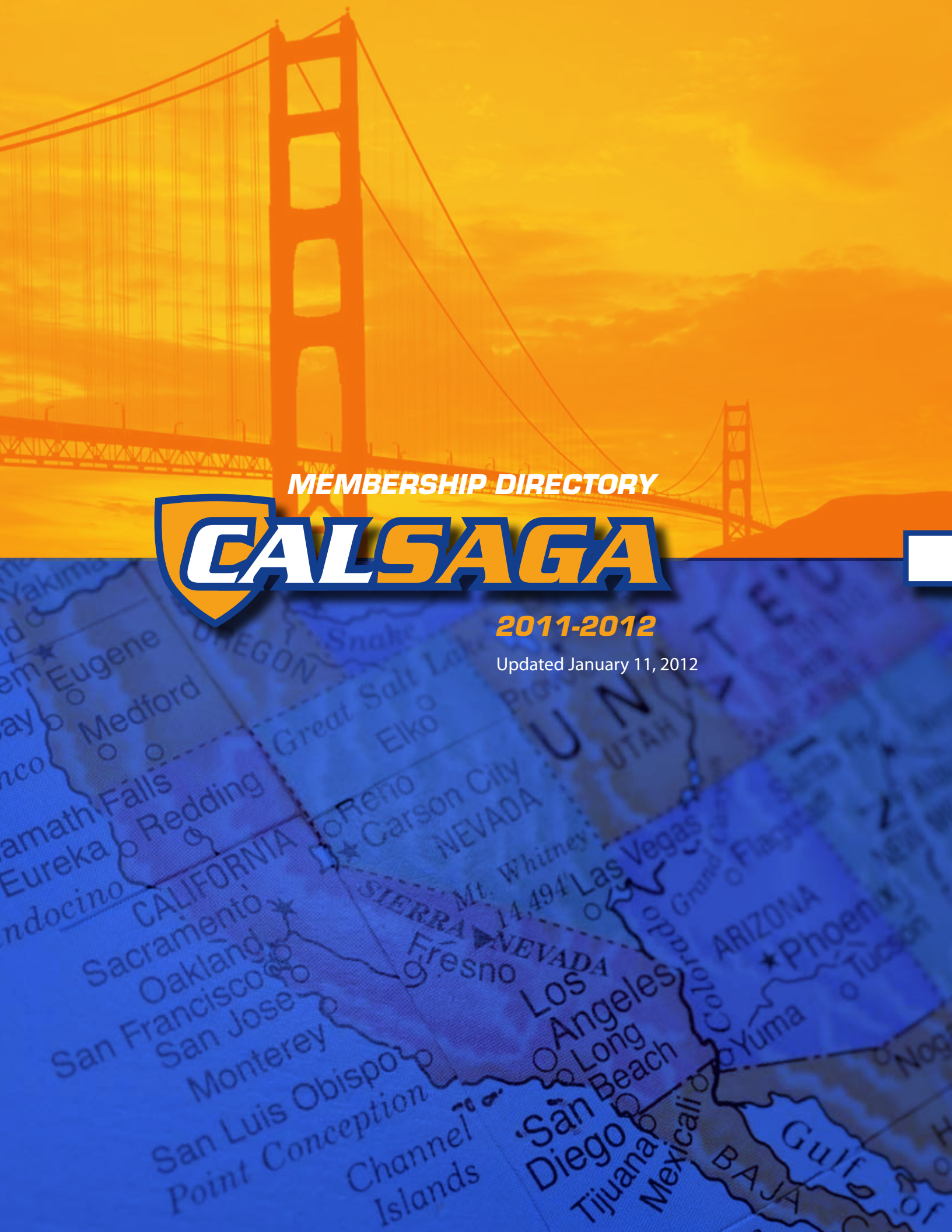



CALSAGA PPO/PSE Membership

Full (voting) CALSAGA membership is open to California licensed Private Patrol Operators (PPOs), California licensed Proprietary Security Employers (PSEs), and licensed Private Security Training Facilities (PSTFs). Membership dues are based on the number of licensed guards at each PPO/PSE. Individual (non-voting) membership is open to licensed security officers and nonowner management personnel whose employers are company members. The requirement that an individual’s company be a member may be waived on a case-by-case basis.

Licensing

How do I report unlicensed activity?

CALSAGA is always happy to assist in reporting unlicensed activity to the BSIS. Or you can email the BSIS Unlicensed Activity Action Unit at uaau_bsisunit@dca.ca.gov directly.

Where can individuals learn about registering for a guard card? Can officers register and pay for the guard card online?

The BSIS encourages all interested in applying for a guard card to do so online at the bureau's website, www.bsis.ca.gov/online_services/online_licensing.shtml. You may also pay registration fees online, access Live Scan documents, learn about processing timelines and determine if you are eligible to renew your license online as well.

Training

What training requirements must contract security officers fulfill in order to get their initial guard card? How many hours of training are required to work?

Individuals applying for a guard card must complete 8 hours of initial training made up of 4 hours of Powers to Arrest and 4 hours of Weapons of Mass Destruction. In order for a PPO to employ a guard, it must verify that the officer has completed 16 hours of mandatory training within the first 30 days the officer was employed by that PPO, and 16 additional hours of elective training within the first six months of employment. Upon completion of the initial 40 hours of training, the PPO must verify that the officer has completed 8 hours of continuing education each year.

How are training requirements for proprietary security officers different from contract security officers?

Proprietary security officers must complete a 16 hour course within the first six months of employment or from the date of registration as a proprietary security officer. Upon completion of the 16 hours of training, an officer must complete 2 hours of continuing education each year thereafter in order to be eligible to work.

How often do I need to renew my PPO license? How often do I need to renew my guard card?

PPO licenses and security guard cards are valid for two years.

Who would be reprimanded if the BSIS determines that an employed officer is working under a revoked or non-current license, or is working without having completed the required training?

The PPO is responsible for maintaining training records and verification of valid guard cards for all employed and active security officers.

Where can I purchase BSIS approved training material to keep my employees current with training requirements?

CALSAGA offers training curriculum for both contract and proprietary security officers that comply with state-mandated initial and continuing education requirements. Training materials may be purchased from CALSAGA by a licensed PPO, PSE or Training Facility.

Does CALSAGA offer study material for the PPO license exam?

CALSAGA, at this time does not offer study material for the PPO license exam.
